# LAW AMENDING THE AVIATION ACT

# Article 1

In the Aviation Act ("Official Gazette of the Republic of Macedonia" No 14/2006, 24/2007, 103/2008, 67/2010, 24/12, 80/12, 155/12, 42/14 and 97/15) in Article 188, paragraph (1) the words: "2000 to" shall be deleted.

Paragraph (2) shall be amended and shall read as follows:

"(2) A fine in the amount of 30% from the established fine for the legal entity for the infringement referred to in paragraph (1) of this Article shall be imposed to the responsible person in the legal entity."

## Article 2

In Article 189 the words: "2000 to" shall be deleted.

Paragraph (2) shall be amended and shall read as follows:

"(2) A fine in the amount of 30% from the established fine for the legal entity for the infringement referred to in paragraph (1) of this Article shall be imposed to the responsible person in the legal entity."

Paragraph (3) shall be amended and shall read as follows:

"(3) A fine in the amount from 1000 to 1500 Euros in Denar equivalent shall be imposed to a physical entity for the infringement referred to in paragraph (1) of this Article."

#### Article 3

In Article 190 paragraph (1) the words: "600 to 2000" shall be replaced with the words: "600 to 1200".

In paragraph (3) the words: "from one to five years: shall be replaced with the words: "to one year".

#### Article 4

Article 190-a shall be amended and shall read as follows:

### "Article 190-a

"(1) For the infringements referred to in Articles 188, 189 and 190 of this Act, before submitting the request for initiating infringement procedure before a competent court, a procedure for reconciliation with issuing an infringement payment order in accordance with the Law on Infringements shall be carried out.

(2) The Agency shall keep records for the issued infringement payment orders as well as for the outcome of the procedure.

(3) In the records referred to in paragraph (2) of this Article the following data shall be collected, processed and kept: name and last name, that is title of the infringer, domicile, that is residence, seat, type of infringement and number of the number of the infringement payment order which is issued.

(4) The personal data referred to in paragraph (3) of this Article shall be kept five years from the day of entry into the records.

(5) The form and the contents of the infringement payment order shall be prescribed by the Director General of the Agency."

### Article 5

A new Article 190-b shall be added after the Article 190-a, which shall read as follows:

# "Article 190-b

The determination of the amount of the fine for the legal entity shall be performed in accordance with the Law on Infringements."

### Article 6

The by-law established by this law shall be enacted within 30 days from the day of entry into force of this law at the latest.

### Article 7

The Legislative-Legal Commission of the Assembly of the Republic of Macedonia shall be authorized to establish a consolidated text of the Aviation Act.

#### Article 8

This Law shall enter into force on the day it is published in the "Official Gazette of the Republic of Macedonia".
