In accordance with subparagraph 7 paragraph 1 from Article 14 of the Aviation Act ("Official Gazette of the Republic of North Macedonia No. 14/24), the Management Board of the Civil Aviation Agency on its 77th Session held on 27 September 2024, enacted the following

TARIFF REGULATION FOR DETERMINING THE AMOUNT OF CHARGES OF THE CIVIL AVIATION AGENCY

1. GENERAL PROVISIONS

Article 1

This Tariff Regulation determines the amount of charges paid to the Civil Aviation Agency regarding the issuance, revalidation, renewal, modification and/or transfer of certificates and other administrative acts (certificates, licenses, approvals, permissions, consents and other), charges for continuing oversight for establishing continuous implementation of the conditions for maintaining the validity of the issued certificates and other administrative acts and the charges from each passenger departing from the airports in the Republic of North Macedonia in accordance the Aviation Act, as well as the method of their calculation and the terms of payment.

Article 2

The amount of charges determined by this Tariff Regulation is used for the Civil Aviation Agency (hereinafter referred to as: the Agency) functioning, investment and ongoing maintenance, for training and professional development and aviation advancement.

2. CHARGES FOR ISSUANCE, REVALIDATION, RENEWAL, MODIFICATION AND/OR TRANSFER OF CERTIFICATES AND OTHER ADMINISTRATIVE ACTS

Article 3

(1) The charges for the issuance, revalidation, renewal, modification and/or transfer of certificates and other administrative acts (certificates, licences, approvals, consents and other) shall refer to the administrative costs and costs for initial oversight arising in a procedure upon specified request.

(2) Charges from paragraph (1) of this Article, shall be paid upon the submission of an application for the issuance, revalidation, renewal, modification and/or transfer of certificates and other administrative acts. The state institutions (MD, MIA, M-NAV, SGCA, etc.) may pay the charges from paragraph (1) of this Article after the procedure is completed, and upon submission of an invoice. These institutions may pay all invoices in a single payment by the end of the current year.

(3) If the Agency acts beyond the territory of the Republic of North Macedonia upon a request for which a charge is set or a foreign legal entity or physical person is engaged to act on behalf of the Agency, the amount of charge specified in this Tariff Regulation is increased by the amount of the costs incurred in relation with that act (transport, accommodation, travelling expenses and engagement).

(4) The amount of charges for the issuance, revalidation, renewal, modification and/or transfer of documents and other administrative acts shall be set in the following areas:

1. Air navigation service charges;
2. Flight operation charges;
3. Airport charges;
4. Security and facilitation charges;
5. Airworthiness and aircraft register charges;
6. Licensing and aviation medicine charges;
7. Flight approvals charges.

2.1. Air Navigation Service Charges

2.1.1 The charge for issuance, modification and/or transfer of a certificate of competence for provision of ATM/ANS services

Article 4

ANS 1	(1) The amount of charges for issuance, modification and/or transfer of a certificate of competence for provision of ATM/ANS services is 0,1% of the total revenue of the ATM/ANS services provider, as the applicant, generated in the previous business year by providing ATM/ANS services according to the data from the official annual financial reports (year preceding the year in which the request for issuance of the certificate is submitted).
ANS 2	(2) The amount of charge for continuous oversight over the compliance with of the conditions for providing ATM/ANS services is paid annually and consists of two parts, the part of the charges financed by En-Route Charges and part of the charges financed by the Terminal Charges.
ANS 3	(3) The part of the charge used to finance the En Route Charges from paragraph (2) of this Article is determined annually in accordance with paragraph 2 of Article 21 of the Aviation Act.

ANS 4	(4) The part of the charge used to finance the Terminal Charges from paragraph (2) of this Article is the charge used to finance the Terminal Charges and is 10% of the total charge collected by the ATM/ANS services provider in accordance with paragraph (4) of Article 58 of the Aviation Act.

Article 5

ANS 5	The amount of charge for recognition of the certificate of competence to provide air navigation services issued by another State in case of delegating the right for provision of air navigation services to another foreign entity on the basis of an international agreement according to Article 59 of the Aviation Act, shall be calculated annually with the budget breakdown and charged at the same manner as defined in Article 4 of this Tariff Regulation.

2.2. Flight Operation Charges

2.2.1 Commercial Air Transport – CAT Charges

Article 6

OPS 1.1	(1) The charge for issuance of an Operating Licence shall amount 2.000 € (123.600 MKD).
OPS 1.2	(2) The charge for renewal of an Operating Licence shall amount 1000 € (61.800 MKD).
OPS 1.3	(3) The amount of charge for modification of an Operating Licence shall amount 2000 € (123.600 MKD).

Article 7

(1) The charge for the issuance of an Air Operator's Certificate (AOC) is determined by summing of the following elements:

OPS 1.4	1. Fixed portion of the charge in an amount of 5 000 € (309.00 MKD). As an exemption for the issuance of an Air Operator's Certificate (AOC) for operations from point A to point A (panoramic flights), the fixed portion of the charge shall amount 1000 € (61.800 MKD);
	2. variable portion of the charge depending on the number and category of aircraft listed in the certificate for which the application has been submitted.

(1) The amount of the charge for accepting a declaration for performing Commercial Specialized Aircraft Operation – SPO is determined by summing three elements from the following ones:

Article 54

The Agency employees who obtain, revalidation or renew licenses, ratings or authorizations, take skill tests, or undergo medical examinations shall be exempted from charges specified under this Tariff Regulation.

(2) The charge from paragraph (1) of this Article shall be paid prior to the issue of flight approval.

3. CHARGES RELATED TO CONTINUOUS OVERSIGHT FOR ESTABLISHING CONTINUOUS COMPLIANCE WITH THE REQUIREMENTS FOR MAINTAINING THE VALIDITY OF ISSUED DOCUMENTS AND ADMINISTRATIVE ACTS

Article 56

(1) Charges for the continuous oversight are intended to cover the oversight expenses that Agency has for conducting an oversight to determine the continuous compliance with the requirements regarding the maintenance of the validity of issued documents and administrative acts (certificates, licences, authorizations, approvals and other), and which oversight is conducted in accordance to the Inspection Oversight Programs.

(2) The charges for the continuous oversight shall be paid only for approved application for issuance, revalidation, renewal, modification and/or transfer of a certificate, authorization or other similar documents.

(3) Notwithstanding to paragraph (1) of this Article, the continuous oversight charges shall not be applied for documents or other administrative acts which are not subject of continuous oversight by the Agency for determination of the continuous compliance of the requirements regarding the maintenance of the validity of the said documents, when this is laid down with the by-laws in the field of aviation.

(4) The applicant shall be obliged to pay the continuous oversight annual charge prior to the receipt of the decision on issue, revalidation/renewal or modification of a respective certificate, authorization or other similar document applied for.

Article 57

(1) The annual amount of charge for continuous oversight over the compliance with the requirements for maintenance of the validity period of issued documents and other administrative acts shall amount 30% of the amount of the charge for their issuance laid down in Chapter 2 of this Tariff Regulation, which increases or decreases proportionally to the period for which the relevant certificate, approval, consent or similar was issued.

(2) Notwithstanding to paragraph (1) of this Article, the annual amount of charge of over the compliance with the requirements for maintenance of the validity period of issued documents and other administrative acts for training organizations shall be:

- 10 € (618 MKD) for the training organizations for glider pilots, free balloon pilots, free flight wings, ultralight aircraft pilots and parachutes;
- 200 € (12.360 MKD) for Flight Training Organization (FTO), Type Rating Training Organisations (TRTOs), F/E and F/N training organisation, Air Traffic Controller, ATSEP, meteo, AIS and FMP personnel;

(3) Notwithstanding paragraph (1) of this Article, the annual amount of charge for continuous oversight over the compliance with the requirements for maintenance of the validity

period of issued documents and other administrative acts in the field of navigation is determined in accordance with Article 4 of this Tariff Regulation.

(4) Notwithstanding paragraph (1) of this Article, the amount of charge for continuous oversight over the compliance with the requirements for maintenance of the validity period of issued documents and other administrative acts in the field of flight operations is determined in accordance with Articles 7, 10, 13 and 17 of this Tariff Regulation.

(5) Notwithstanding paragraph (1) of this Article, the amount of charge for continuous oversight over the compliance with the requirements for maintenance of the validity period of issued documents and other administrative acts in the field of aerodromes is determined in accordance with Articles 18, 19, 20, 24 and 25 of this Tariff Regulation.

4. CHARGE PER DEPARTING PASSENGER FROM THE AIRPORTS IN THE REPUBLIC OF NORTH MACEDONIA

Article 58

(1) The charge per departing passenger from the airports in the Republic of North Macedonia is intended to compensate the oversight costs of the Agency during the implementation of the regulations not covered by other charges laid down in this Tarif Regulation, for training and professional development of the Agency's employees, aviation enhancement, as well as for other costs required for the functioning of the Agency.

(2) The charge from paragraph (1) of this Article, paid by departing passengers from airports in the Republic of North Macedonia, is in an amount of 0.98 EUR per passenger in the international air traffic. Air carriers shall collect this charge on their behalf and for the interest of the Agency (charge calculated in the air tickets fare).

(3) The name of the charge from paragraph (1) of this Article in English shall read as: Macedonian Civil Aviation Tax (MKCAA Tax).

(4) The charge from paragraph (1) of this Article shall be published in the Aeronautical Information Publication (AIP).

(5) The method and calculation of the charge for a departing passenger shall be carried out according to the prescribed procedure/manual of the Agency pursuant to Article 63 of this Tariff Regulation.

(6) In any case where the passenger has not departed from the airports in the Republic of North Macedonia (regardless of whether the transportation cancelled before or after the departure date, as well as regardless of whether the tax includes a return or retention of the paid assets), the charge from paragraph (1) of this Article shall be returned (refunded).

(7) In the event of re-issuance of a ticket, the charge from paragraph (1) of this Article which is billed to the passenger, shall be acknowledged to the modification/re-issuance of the ticket.

(8) The following passengers are exempt from the charges from paragraph (1) of this Article:

- in the event when the operating aircraft was returned to the departing airport due to *force majeure* (any type of *force majeure* is base for an exemption);
- flights operated by aircraft with a capacity of less than 20 seats;
- all children up to two years, regardless of whether they have a seat or not;
- transit passengers (transfer passengers are not exempted) and

passengers with service tickets (ID 00, ID90).

5. COMMON PROVISIONS

Article 59

The amount of the charges determined under this Tariff Regulation shall be expressed in Euro/denars, and be paid to the account of the Civil Aviation Agency of the Republic of North Macedonia.

Article 60

(1) The Director General of the Agency may, based on a written request by an aviation industry entity, approve deferred payment for a period not longer than the validity of the issued document, provided that the deferment does not jeopardize the financial liquidity of the Agency.

(2) The applicant who has been granted deferred payment shall be furnished with an invoice by the Agency, stating a reference to the approved deferment payment request, total prescribed charge as well as the deadline and dynamism of payment.

(3) Physical persons subject to payment of the charges determined under this Tariff Regulation may submit request for exemption from payment. The Director General of the Agency shall make a decision on exemption from payment upon receiving of a prior consent by the Management Board of the Agency, provided that such exemption does not jeopardize the financial liquidity of the Agency.

Article 61

(1) The applicant of the request from Article 60 of this Tariff Regulation, as well as the applicant obligated to payment of the charge specified under this Tariff Regulation, failing to perform the payment within the period specified in the invoice, shall be furnished with a late payment notification by the Agency, stating a payment period not longer than 15 days.

(2) In the event the applicant of the request from paragraph (1) of this Article fails to make the payment within the additional payment period, the Agency shall take measures in accordance with the applicable laws.

Article 62

In the event the employees of the Agency acts at a request for technical or professional assistance submitted by a domestic or foreign physical or legal person, the amount of the charge for the technical assistance provided by the Agency shall be established in an agreement.

Article 63

The internal organization of the Agency regarding the accounting and collection of the charges specified under this Tariff Regulation shall be established by an internal procedure/manual enacted by the Agency Director General.

6. TRANSITIONAL AND FINAL PROVISIONS

Article 64

(1) The provisions of this Tariff Regulation relating to the issuance of an unmanned aircraft registration certificate, with the exception of the certificate for an unmanned aircraft whose design is subject to certification, shall apply until the entry into force of the Regulation on Unmanned Aircraft.

(2) The provisions of Chapter 4 of this Tariff Regulation shall apply from 30.03.2025.

Article 65

On the day of the commencement of the application of this Tariff Regulation, the Tariff Regulation specifying the amount of charges of the Civil Aviation Agency (No. 02-398/2 dated 14.03.2017), the Tariff Regulation for amending the Tariff Regulation specifying the amount of charges of the Civil Aviation Agency (No. 02-356/2 dated 26.02.2018), the Tariff Regulation for amending the Tariff Regulation specifying the amount of charges of the Civil Aviation Agency (No. 02-2089/2 dated 27.12.2018), the Tariff Regulation for amending the Tariff Regulation specifying the amount of charges of the Civil Aviation Agency (No. 02-853/2 dated 24.06.2019), the Tariff Regulation for amending the Tariff Regulation specifying the amount of charges of the Civil Aviation Agency (No. 02-1144/2 dated 19.08.2019), the Tariff Regulation for amending the Tariff Regulation specifying the amount of charges of the Civil Aviation Agency (No. 02-1696/2 dated 10.12.2019), the Tariff Regulation for amending the Tariff Regulation specifying the amount of charges of the Civil Aviation Agency (No. 02-640/3 dated 28.09.2020), the Tariff Regulation for amending the Tariff Regulation specifying the amount of charges of the Civil Aviation Agency (No. 02-260/2 dated 11.03.2021) and the Tariff Regulation specifying the amount of charges of the Civil Aviation Agency (No. 02-1132/2 dated 30.09.2024) shall cease to be valid.

Article 66

On the day of entry into force of this tariff, the procedures that have not been completed according to the provisions of the Tariff Regulation for specifying the amount of charges of the Civil Aviation Agency (No. 02-398/2 dated 14.03.2017, No. 02-356/2 dated 26.02.2018, No. 02-2089/2 dated 27.12.2018, No. 02-853/2 dated 24.06.2019, No. 02-1144/2 dated 19.08.2019, No. 02-1696/2 dated 10.12.2019, No. 02-640/3 dated 28.09.2020 and No. 02-260/2 dated 11.03.2021), will be completed according to this Tariff Regulation, taking into account being more favourable to the applicant.

Article 67

This Tariff Regulation shall enter into force on the date of its promulgation and shall start to apply from 1 January 2025.
