In accordance with Article 48 of the Aviation Act ("Official Gazette of the Republic of North Macedonia" No. 14/24, 224/24, 3/25 and 144/25), and in reference to Article 3 of the Multilateral Agreement between the European Community and its Member States, the Republic of Albania, Bosnia and Herzegovina, the Republic of Bulgaria, the Republic of Croatia, the Republic of Macedonia, the Republic of Iceland, the Republic of Montenegro, the Kingdom of Norway, Romania, the Republic of Serbia and the United Nations Interim Administration Mission in Kosovo on the establishment of a European Common Aviation Area ratified with the Act of Ratification of Multilateral Agreement ("Official Gazette of the Republic of Macedonia No. 27/07 and 98/09 and "Official Gazette of the Republic of North Macedonia" No. 259/19) the Director General of the Civil Aviation Agency enacted

REGULATION

ON THE RULES FOR ESTABLISHMENT OF A LIST OF AIR CARRIERS SUBJECT TO AN OPERATING BAN

Article 1

This Regulation establishes the rules for establishment of a list of air carriers subject to an operating ban.

Article 2

- (1) The rules for establishment of the list of air carriers subject to an operating ban in the Community (hereinafter: Community list) are laid down in the Chapter II of the Regulation (EC) No. 2111/2005 of the European Parliament and of the Council of 14 December 2005 on the establishment of a Community list of air carriers subject to an operating ban within the Community and on informing air transport passengers of the identity of the operating air carrier, and repealing Article 9 of Directive 2004/36/EC, amended by Regulation (EU) No. 2018/1139 (hereinafter: Regulation No. 2111/2005), Commission Regulation (EC) No. 473/2006 of 22 March 2006 laying down implementing rules for the Community list of air carriers which are subject to an operating ban within the Community referred to in Chapter II of Regulation (EC) No. 2111/2005 of the European Parliament and of the Council (hereinafter: Regulation No. 473/2006) and Commission Regulation (EC) No. 474/2006 of 22 March 2006 establishing the Community list of air carriers which are subject to an operating ban within the Community referred to in Chapter II of Regulation (EC) No. 2111/2005 of the European Parliament and of the Council amended by Regulation (EU) No. 2025/1144 (hereinafter: Regulation No. 474/2006), accepted and directly applied and published on the Civil Aviation Agency's website.
- (2) The air carriers listed in the Community list shall not perform operation on the territory of the Republic of North Macedonia.

Article 3

(1) The terms "Community", "Community aw", "Community Legislation", "Community Instruments", "EC Treaty", "Community airport", "Official Journal of the European Communities", "Official Journal of the

European Union", "Community air carrier" and "Member State(s)" used in Regulations No. 2111/2005, 473/2006 and 474/2006 from Article 2 of this Regulation are read in accordance with points 2 and 3 of the Annex II of the Multilateral Agreement between the European Community and its Member States, the Republic of Albania, Bosnia and Herzegovina, the Republic of Bulgaria, the Republic of Croatia, the Republic of Macedonia, the Republic of Iceland, the Republic of Montenegro, the Kingdom of Norway, Romania, the Republic of Serbia and the United Nations Interim Administration Mission in Kosovo on the establishment of a European Common Aviation Area ratified with the Act of Ratification of Multilateral Agreement ("Official Gazette of the Republic of Macedonia No. 27/07 and 98/09 and "Official Gazette of the Republic of North Macedonia" No. 259/19).

(2) Other terms during the implementation of this Regulation shall have the meaning established in the Regulations No. 2111/2005, 473/2006 and 474/2006, from Article 2 of this Regulation.

Article 4

- (1) The Civil Aviation Agency is the competent authority on the territory of the Republic of North Macedonia for the application of the operating bans contained in the Community list in relation to air carriers subject to such bans.
- (2) The Civil Aviation Agency shall notify the European Commission of the identity of air carriers subject to an operating ban on the territory of the Republic of North Macedonia, together with the reasons for such ban and other relevant information.
- (3) The Civil Aviation Agency shall notify the European Commission of all information that may be of importance for updating the Community list, in accordance with the rules contained in Regulation No. 473/2006.
- (4) In case of urgency, the application of the provisions of Regulation No. 2111/2005 shall not prevent the Civil Aviation Agency from acting in the event of an unforeseen safety problem by imposing an immediate operating ban in relation to the territory of the Republic of North Macedonia, taking into account the common criteria laid down in the Annex to Regulation No. 2111/2005. The Civil Aviation Agency shall prepare working procedure in order to ensure the implementation of the Annex to Regulation No. 2111/2005.
- (5) The decision of the European Commission not to include a specific air carrier in the Community list in accordance with the procedure laid down in Regulation No. 2111/2005 shall not prevent the Civil Aviation Agency from imposing an operating ban on an air carrier in relation to safety problems specific to the Republic of North Macedonia.
- (6) In the cases referred to in paragraphs (4) and (5) of this Article, the Civil Aviation Agency shall immediately notify the European Commission.
- (7) For the cases referred to in paragraph (4) of this Article, the Civil Aviation Agency shall submit to the European Commission a request for updating the Community list.

Article 5

On the date of entry into force of this Regulation, the Regulation on the rules for establishment of a list of air carriers subject to an operating ban ("Official Gazette of Republic of North Macedonia" No. 233/23) shall cease to be applied.

Article 6

This Regulation shall enter into force on the day following its publication in the "Official Gazette of the Republic of North Macedonia".
