LAW
ON AMENDMENT TO THE AVIATION ACT

Article 1

In the Aviation Act („Official Gazette of the Republic of North Macedonia“, No. 14/24), in indent 1, paragraph (1) of Article 5, the words “Ministry of Transport and Communications” shall be substituted by the words "Ministry of Transport".

Article 2

In paragraph (1) Article 6, in the introductory sentence, the words “Ministry of Transport and Communications” shall be substituted by the words "Ministry of Transport".

Article 3

In paragraph (3) Article 25, the words “Ministry of Transport and Communications” shall be substituted by the words "Ministry of Transport".

Article 4

In the indent 7, paragraph (2) of Article 29, the words “Ministry of Transport and Communications” shall be substituted by the words "Ministry of Transport".

Article 5

In paragraph (2) Article 30, the words “Ministry of Transport and Communications” shall be substituted by the words "Ministry of Transport".

Article 6

In paragraph (4) Article 41, the words “Ministry of Foreign Affairs” shall be substituted by the words "Ministry of Foreign Affairs and Foreign Trade".

Article 7

In paragraph (3) Article 60, the words “Ministry of Transport and Communications” shall be substituted by the words "Ministry of Transport".

Article 8

In paragraph (3) Article 82, the words “Minister of Transport and Communications” shall be substituted by the words "Minister of Transport".

Article 9

In paragraph (2) Article 92, the words “Ministry of Transport and Communications” shall be substituted by the words "Ministry of Transport".

Article 10

In paragraph (1) Article 96, in the introductory sentence, the words “Ministry of Transport and Communications” shall be substituted by the words "Ministry of Transport".

In paragraph (2), the words “Ministry of Transport and Communications” shall be substituted by the words "Ministry of Transport".

Article 11

In the indent 6, paragraph (2) of Article 96, the words “Ministry of Transport and Communications” shall be substituted by the words "Ministry of Transport".

In point 13), paragraph (1) of Article 159, the words “Minister of Transport and Communications” shall be substituted by the words "Minister of Transport".

Article 17

This Law shall enter into force on the day following its publication in the "Official Gazette of the Republic of North Macedonia".
